

2020 competition Fact sheet (to be held in 2021)

Issue date: April 2020

Who can apply for the 2020 part of the DWC finals competition?	 Any dancer who attended the 2020 country qualifier of their country and obtained a mark of 70 or above. Any dancer whose country does not hold a qualifier or has not been able to hold one in 2020 and has requested to qualify by video entry for DWC and has received a qualified mark. Please contact head office for more information dance@dwcworld.com Video entries must be submitted to DWC no later than 05 October 2020.
Event Fee:	 Event fee for 2020 competition: 60 euro per dancer If you are competing in both the 2020 and the 2021 competition, the event fee will be 90 euros per dancer which will cover both competitions. This is a compulsory fee* Membership fees for 2020 are 10 euros per dancer
Dance Fees:	 60 euro per solo 30 euro duet/trio (per dancer) 20 euro group (per dancer)
Payment for final entries	 All entries for 2020 must be registered on the DWC finals system by 31 October 2020. Payment for the finals entries for 2020, must be received no later than 30 November 2020. If payment has not been received by this date, DWC will assume that you no longer wish to attend and we have the right to offer the spaces to another school on the waiting list.

Payment for final entries cont:	 All dance schools registered on the DWC finals system can automatically generate an invoice through their personal account.
Cancellation of entries:	 Each dance school will have until 30 November 2020 to cancel their registration at no cost should they decide not to attend the 2020 competition in 2021. Please note, cancellation by a dance school once payment has been made cannot be refunded unless due to a medical condition and covered by a medical letter.
Age requirements for 2020 competition:	 All ages are based on the age of the dancer as of <u>01 January</u> <u>2020</u>. All dancers will dance in the correct age category as they would have done in the original 2020 competition.
Country entries 2020:	Country entries 2020: For the 2020 competition only. All countries can have up to six entries per class. The Qualifying mark for entry to the DWC finals is 70 and above The six highest marked routines performed at the qualifier for each class, confirming to attend the DWC finals, will be accepted. Should spaces become available within this six, after the closing date, the qualifier organiser will offer the spaces to the next routines in line that have obtained 70 marks or above.
Soloists for 2020	 Soloists can enter a maximum of 5 solos. These must not be in the same class.
Country/Venue for 2020/2021	 We will hope to advise all dance schools when and where the competition will be held by the end of September/early October. This is of course dependant on whether countries have recovered from Covid-19 and are allowing travel.

Dates for 2020/2021 competition:	 The dates that we are looking for next year will be any time between: 25 June and up to 13 August 2021. We hope to advise all dance schools of the confirmed dates of the competition, by the end of September/early October 2020.
Schedule 2020:	A provisional schedule will be released no later than 01 March 2021 for the 2020 part of the competition.
Galas:	 We will be holding 4 galas for the 2020 competition. 1 x theatrical and 1 x classical for the mini and children section and 1 x theatrical and 1 x classical for the junior and senior section.
Personal insurance:	It is the responsibility of each family to take out travel insurance for travel and accommodation.
Possible future cancellation:	 If the final event has to be cancelled again, DWC will refund all monies that has been paid in the form of credit notes for future competitions.

General:

- DWC reserves the right to amalgamate the 2020 and 2021 competition if we do not receive enough registrations to hold two separate competitions.
- The same choreography performed in the 2020 competition cannot be performed again in the 2021 competition.
