



## **Dance World Cup Registration Terms and Conditions 2026**

### **1. Terms and Conditions of Registration**

This document sets out the terms and conditions that apply to registration with Dance World Cup (DWC) and is entered into with the named individual.

DWC Limited reserves the right to update these terms and conditions at any time and will communicate any material changes to dance schools within an appropriate time frame.

Registration with DWC allows dancers to enter a country qualifier and, if successful, the DWC Finals. Registration is not a subscription programme and does not provide ongoing benefits beyond entry eligibility for the relevant competition season.

All dance schools may apply for their students to register with DWC. Registering with DWC carries no legal responsibility towards DWC Limited, and it does not grant any voting rights or liability in respect of DWC Ltd or its debts.

Applications from new registrations will be processed as promptly as possible.

DWC Limited will notify dance schools when registrations for a season open and will provide any required information relating to the process and payment methods.

Registration is not transferable and registration fees are non-refundable. Dancers may withdraw their registration at any time, but no refund will be issued for any unused portion of the competition season.

DWC Limited reserves the right to cancel a registration should we anticipate that it will not be possible to continue offering competition entry services for a continuous period of 90 days or more. Reasonable notice will be provided where possible.

DWC Limited accepts no liability whatsoever for any harm, damage, or loss, howsoever caused, arising from participation in DWC events.

These terms shall be governed by and construed in accordance with the laws of Jersey, Channel Islands. The courts of Jersey shall have exclusive jurisdiction over any claim, action, or dispute arising out of or connected with these terms, and each party irrevocably submits to this jurisdiction.



## **2. Privacy Policy**

Through the registration process, DWC Limited will collect the required personal data about the dancer and/or the dance school. We undertake to take all reasonable measures to protect this data whilst it is in our care.

When you register a dancer, we collect only the information required to administer their competition entry. We do not collect sensitive data (race, ethnic origin, religious beliefs etc).

Marketing communication is based on dance school contact data only. We will not share a dancer's personal data with third parties unless we have explicit permission to do so.

A registered individual has the right to access their personal data held by DWC. Any request for this should be directed to [dance@dwcworld.com](mailto:dance@dwcworld.com)

## **3. Permissions**

By completing the dancer's registration, the dance school confirms that the dancer (or the parent/guardian for minors) gives permission for DWC Limited, or those contracted by DWC, to video and photograph the dancer.

The dancer grants permission for these videos and photographs to be used on DWC's websites, livestreams, social media channels, and promotional materials.

DWC Limited may provide dancer details to DWC's official sponsors. Should the dancer or parent/guardian not wish for details to be shared, they must notify DWC by email at [dance@dwcworld.com](mailto:dance@dwcworld.com)

All dance activity is undertaken at the dancer's own risk. Any injuries arising from participation are the sole responsibility of the dancer, and DWC Limited cannot be held liable.

By completing the registration, the dance teacher/school accepts these terms and conditions on behalf of all registered students. It is the responsibility of the school/teachers to obtain permission from the dancer or parent/guardian before submitting their registration.
